WHEREAS, Cuyahoga County received \$239,898,257 from the Federal Government through the American Rescue Plan Act ("ARPA"); and

WHEREAS, Cuyahoga County calculated 100% of the ARPA dollars as loss revenue under the U.S. Department of the Treasury Final Rule; and

WHEREAS, since all the ARPA dollars have been calculated as loss revenue, the ARPA dollars have been deposited in the County's General Fund; and

WHEREAS, the County Executive and County Council have authorized \$86 million of the ARPA dollars for community grants to benefit the residents of Cuyahoga County (the "ARPA Community Grant Fund"); and

WHEREAS, of the \$86 million for community grants, \$66 million have been encumbered for equal distribution to each County Council District; and

WHEREAS, the Cuyahoga County Council desires to provide funding from the District 8 ARPA Community Grant Fund in the amount of \$70,000 to the Greater Cleveland Faith Based Initiative Group for the Project Reach Anti-Violence Program; and

WHEREAS, the Greater Cleveland Faith Based Initiative Group estimates approximately 36,000 to 50,000 people will be served annually through this award; and

WHEREAS, the Greater Cleveland Faith Based Initiative Group estimates approximately 150 to 200 permanent and temporary jobs will be created or retained through this project; and

WHEREAS, the Greater Cleveland Faith Based Initiative Group estimates the total cost of the project is \$87,500; and

- WHEREAS, the Greater Cleveland Faith Based Initiative Group indicates the other funding source(s) for this project includes funding for summer food programs from Catholic Charities, payroll for summer jobs from Youth Opportunities Unlimited, and in-kind services from the ten faith based organizations; and
- **WHEREAS**, the Greater Cleveland Faith Based Initiative Group is estimating the start date of the project will be June 2023 and the project will be completed by June 2024; and
- **WHEREAS**, the Greater Cleveland Faith Based Initiative Group requested \$70,000 from the District 8 ARPA Community Grant Fund to complete this project; and
- WHEREAS, the Cuyahoga County Council desires to provide funding in the amount of \$70,000 to the Greater Cleveland Faith Based Initiative Group to ensure this project is completed; and
- WHEREAS, this Council by a vote of at least eight (8) members determines that it is necessary that this Resolution become immediately effective in order that critical services provided by Cuyahoga County can continue to provide for the usually, daily operations of the County.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CUYAHOGA COUNTY, OHIO:

- **SECTION 1.** That the Cuyahoga County Council hereby awards a not-to-exceed amount of \$70,000 to the Greater Cleveland Faith Based Initiative Group from the General Fund made available by the American Rescue Plan Act revenue replacement provision for the Project Reach Anti-Violence Program.
- **SECTION 2.** If any specific appropriation is necessary to effectuate this agreement, the Director of the Office of Budget and Management is authorized to submit the requisite documentation to financial reporting to journalize the appropriation.
- **SECTION 3.** That the County Council staff is authorized to prepare all documents to effectuate said award.
- **SECTION 4.** That the County Executive is authorized to execute all necessary agreements and documents consistent with said award and this Resolution.
- **SECTION 5.** If requested or necessary, the Agency of the Inspector General or Department of Internal Audit is authorized to investigate, audit, or review any part of this award.

SECTION 6. To the extent that any exemptions are necessary under the County Code and contracting procedures, they shall be deemed approved by the adoption of this Resolution.

SECTION 7. It is necessary that this Resolution become immediately effective for the usual daily operation of the County; the preservation of public peace, health or safety in the County; and any additional reasons set forth in the preamble. Provided that this Resolution receives the affirmative vote of at least eight members of Council, it shall take effect and be in force immediately upon the earliest occurrence of any of the following: (1) its approval by the County Executive through signature, (2) the expiration of the time during which it may be disapproved by the County Executive under Section 3.10(6) of the Cuyahoga County Charter, or (3) its passage by at least eight members of Council after disapproval pursuant to Section 3.10(7) of the Cuyahoga County Charter. Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

SECTION 8. The Greater Cleveland Faith Based Initiative Group proposes the "Project Reach Anti-Violence Program". Our programs consist of linking together churches and non-profit organizations to "Bridge the Gap" and bring awareness to the heighten areas of violence in our communities. We have (5) five-year initial year-round programs that will reach thousands throughout many of our cities and Cuyahoga community county.

The job opportunities consist of: Teachers Aid, Data Entry, Receptionist, Food Service, Landscaping, Janitorial Service, Recreational Aid, Field Trip Monitors, and summer camp staff. The jobs will be provided through our faith-based organizations and collaborative partnerships with year-round job placement opportunities.

The Fourth Program is our <u>Mentorship Program</u> the faith-based initiative collaborative will Bridge The Gap by providing mentors who will provide counseling in the areas of: Motivation, Direction, Coaching, Inspiration, Workforce Training, Violence Prevention, and Success Resolutions.

The Fifth Program is the <u>AGAPE Awards</u>. The purpose of the Agape Awards is to Honor Community Leaders who have come together to support each other in building and enhancing the lives of Families and Communities through the yearlong collaborative programs. Through these efforts we create an audience that will acknowledge their accomplishments and their tireless efforts in working towards a collaboration of Hope, Faith and Renewed Trust in one another as one community. IMPACT OF PROJECT:

Who will be served:

We will provide services for the youth and young adults through our mentoring and workforce development programs. In addition, we will also serve the Cuyahoga county community at large through our literacy campaign and town hall meetings about violence and forming plans through initiatives and partnerships through the efforts of faith based and other community organizations.

How many people will be served annually:

We will serve from 36,000 -50,000 through the literacy project, we will serve 150-200 youth annually with the summer employment project. We will serve 600 youth annually with the quarterly mentorship project teaching how to go from a job to a career. We will reach 4,000 - 5,000 citizens throughout the county annually with our Townhall meeting. The Agape' Awards will reach 70 honorees 1000-1200 participants and community citizens by bridging the gap bringing together Youth and Young Adult Leaders, Educational Leaders, Community Leaders, Faith Based Leaders, Law Enforcement, Political Leaders & Business Leaders

Will low/moderate income people be served; if so how:

During the summer programs each of our churches will be working with Catholic Charities who will provide summer breakfast and lunch to all communities for ages up to 18-year-olds. In addition, our youth will be employed by the churches through the Youth Opportunities Unlimited summer jobs program.

How does the project fit with the community and with other ongoing projects:

Our project fits in the community by coming together with a collaboration of area Pastors, Faith Based, Business and other Community Leaders to support each other in building and enhancing the lives of families and communities. The GCFBIG programs are an effort to provide Anti-violence initiatives, Employment, offer Job Development Skills, Mentoring, Counseling, Soft Skill Training and Life Skill Training program.

If applicable, how many jobs will be created or retained (specify the number for each) and will the jobs be permanent or temporary: (TEMPORARY JOBS)


We will create 20 Mentor jobs, 150-200 youth summer jobs opportunities, 20 food service managers for summer food program, 100 event planners for the Agape' Awards, 50 event planners for the town hall meetings and 20 facilitators for the literacy campaign.

Our initiatives will draw a better working relationship between the political leaders, law enforcement community leaders, gangs, youth and young adult business community, educational community, faith-based leaders, and citizens of the local community

Our model of Faith Based collaborations will allow the churches which are in abundance in our communities across the county to participate more in initiatives that will help aid families, educational institutions, Government, Faith Based, and the Corporate Communities through state and federal funding. They will now be able to house many great initiatives within so many empty synagogues, mosque, churches and temple's that have been empty since COVID with flourishing programs that can contribute to the rise of a great synergy of collaborations for the common good of humanity. Together this project will serve as the catalyst as a National initiative for collaborations of Pastors, Faith Based and Community Leaders of many Cities within the United States who will come together to support each other in building and enhancing the lives of families and communities.



Youth Opportunities Unlimited will provide the payroll for the summer jobs directly to each student for 6 or more weeks through direct deposits with our local finical institution for our faith-based organizations hiring youth.

The (10) Faith Based organizations will provide in-kind services that will help provide a broader base of income through use of business, volunteers, paid staff, equipment and supplies as well as goods and other services

Project Name: Culturally-sensitive mental health care for Cuyahoga County's Black women **Project Description**: Village of Healing will retain a psychiatric nurse practitioner who will complete intakes and assessments for 80 patients and will have the ability to write prescriptions for patients who need them.

Project Need:

Statistics show 20% of women develop a perinatal mental health illness during pregnancy or in the first year after giving birth. For Black women, that risk is doubled. COVID-19 increased the effects on maternal mental health with the latest data suggesting 70% of pregnant and new moms are being diagnosed with depression and anxiety and 30% suffering from PTSD. Maternal mental health conditions are the number one complication of childbirth affecting over 700,000 women in the US each year. Pregnant and parenting women with mental health complications experience higher rates of infant and maternal mortality, family fragmentation, lack of prenatal care, low social support, financial and housing instability, co-occurring health complications, unmanageable job strain, difficulty meeting maternal role expectations, and childhood or perinatal trauma, including domestic or sexual abuse (Pao, et al., 2018). While maternal mental health complications are more widely addressed in pregnancy-related discussions, Black women often struggle to find their place in the conversation. Data indicates that when support services fit the sociocultural needs of the population served, there is a higher chance that women will engage in care.

Demand for mental health counseling outpaces our therapist's caseload of 55 women. We maintain a waitlist that will immediately fill a second caseload. Hiring a psychiatric nurse practitioner to support women is a top priority.

Milestones/Tracking:

<u>Goal</u>: Reduce barriers to mental health care for Black women in Cuyahoga County by offering culturally-sensitive mental health counseling (1:1 appointments) and prescription management.

Objective 1: 80 women will complete an intake with our psychiatric nurse practitioner; 55 women will self-identify a need for regular counseling.

Objective 2: 80 women will enroll in our Mother to Mother or Professional Black Women's Group programs in 12 months. Among this group, 90% will report reduced anxiety or depression or increased coping skills after 3 sessions.

Each medical patient completes an intake health screening that is considered baseline data. We track critical information to understand mental and physical indicators of health and well-being. Outcomes among women who enroll in our signature programs or mental health counseling are measured by utilizing the Edinburgh Depression scale (EPDS), or screening tools of the provider's choice. Women complete each screening at enrollment and once she completes one of the signature programs. We complete survey evaluations a minimum of three times throughout the course of the program. Utilizing a team based approach, the community health worker and program manager meet during the mentee's enrollment to review progress, address any needs i.e., social determinants of health and appropriate referrals are initiated.

A. Scope of Work Summary

1. The Office of Homeless Services is requesting a first amendment to contract CM 3272 (copy of CM 2730) with Emerald Development and Economic Network, Inc (EDEN) for Rapid Rehousing services for time and additional funds. The original contract was funded through the State of Ohio Homeless Crisis Response Program for the term of January 1, 2022 through December 31, 2023, in the amount of \$1,935,500.00.
