1. CALL TO ORDER

Chairwoman Stephens called the meeting to order at 10:02 a.m.

WHEREAS, Cuyahoga County received \$239,898,257 from the Federal Government through the American Rescue Plan Act ("ARPA"); and

**WHEREAS**, Cuyahoga County calculated 100% of the ARPA dollars as loss revenue under the U.S. Department of the Treasury Final Rule; and

**WHEREAS**, since all the ARPA dollars have been calculated as loss revenue, the ARPA dollars have been deposited in the County's General Fund; and

WHEREAS, the County Executive and County Council have authorized \$86 million of the ARPA dollars for community grants to benefit the residents of Cuyahoga County (the "ARPA Community Grant Fund"); and

WHEREAS, of the \$86 million for community grants, \$66 million have been encumbered for equal distribution to each County Council District; and

WHEREAS, the Cuyahoga County Council desires to provide funding from the District 8 ARPA Community Grant Fund in the amount of \$15,000 to the Friendly Inn Settlement, Inc. for the Friendly Inn Signage project; and

**WHEREAS**, the Friendly Inn Settlement, Inc. estimates approximately 4,000 people will be served annually through this award; and

**WHEREAS**, the Friendly Inn Settlement, Inc. estimates the total cost of the project is \$20,976.80; and

**WHEREAS**, the Friendly Inn Settlement, Inc. indicates the other funding source(s) for this project includes:

- A. \$5,500 from the City of Cleveland, Councilman Starr Ward 5
- B. \$476.80 from Friendly Inn; and

- **WHEREAS**, the Friendly Inn Settlement, Inc. is estimating the start date of the project will be June 2023 and the project will be completed by July 2023; and
- WHEREAS, the Friendly Inn Settlement, Inc. requested \$15,000 from the District 8 ARPA Community Grant Fund to complete this project; and
- WHEREAS, the Cuyahoga County Council desires to provide funding in the amount of \$15,000 to the Friendly Inn Settlement, Inc. to ensure this project is completed; and
- WHEREAS, this Council by a vote of at least eight (8) members determines that it is necessary that this Resolution become immediately effective in order that critical services provided by Cuyahoga County can continue to provide for the usually, daily operations of the County.

# NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CUYAHOGA COUNTY, OHIO:

- **SECTION 1.** That the Cuyahoga County Council hereby awards a not-to-exceed amount of \$15,000 to the Friendly Inn Settlement, Inc. from the General Fund made available by the American Rescue Plan Act revenue replacement provision for the Friendly Inn Signage project.
- **SECTION 2.** If any specific appropriation is necessary to effectuate this agreement, the Director of the Office of Budget and Management is authorized to submit the requisite documentation to financial reporting to journalize the appropriation.
- **SECTION 3.** That the County Council staff is authorized to prepare all documents to effectuate said award.
- **SECTION 4.** That the County Executive is authorized to execute all necessary agreements and documents consistent with said award and this Resolution.
- **SECTION 5.** If requested or necessary, the Agency of the Inspector General or Department of Internal Audit is authorized to investigate, audit, or review any part of this award.
- **SECTION 6.** To the extent that any exemptions are necessary under the County Code and contracting procedures, they shall be deemed approved by the adoption of this Resolution.
- **SECTION 7.** It is necessary that this Resolution become immediately effective for the usual daily operation of the County; the preservation of public peace, health or safety in the County; and any additional reasons set forth in the preamble. Provided that this Resolution receives the affirmative vote of at least eight members of Council, it shall take effect and be in force immediately upon the earliest occurrence of any of

the following: (1) its approval by the County Executive through signature, (2) the expiration of the time during which it may be disapproved by the County Executive under Section 3.10(6) of the Cuyahoga County Charter, or (3) its passage by at least eight members of Council after disapproval pursuant to Section 3.10(7) of the Cuyahoga County Charter. Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

**SECTION 8.** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of the Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

#### Scope of work;

The image below is of your pre-existing sign. My company's approach for the new sign is as follows: We would like to build a sign that will stand to the elements of the weather throughout the seasons. It is our goal to build a sign that is low maintenance. The second image is the sign that we are offering to erect, especially in honor of your 150<sup>th</sup> anniversary.





#### The footer for the sign;

Our first step, once we demolish the current sign, will be to excavate a footer for the new sign. The footer will ensure that the sign will not shift through the freeze and thaw during the season change. The footer will also act as a solid foundation to support the sign and give it strength. Once the footer has been excavated, we will then pour the footer with concrete.

There are different types of concrete in the industry, utilized for specific applications. We will use a concrete mix that has fiber mesh in it. This fiber mesh is high in density and acts as a binding agent for a solid footer.




## Fiber Mesh in Quality Concrete

Fiber mesh is used in mid to higher-quality concrete. The mesh is made up of fibers which include steel fibers, glass fibers, synthetic fibers, and other natural ones. This mesh helps in strengthening the concrete and acts as the tendons and muscles do in our body. The mesh offers strength for a higher result factor when used with the higher composition elements in the mid to higher-grade concrete.










The image below illustrates the concrete poured into the footer.




Once the footer cures, we will begin to build the sign's outer frame using concrete cinder blocks. The first image below illustrates this. The second image illustrates galvanized steel studs. We use these to give the actual backing of the sign strength.





## About your Cultured Stone Veneer

Our manufactured (Class A Series) stones are carefully selected from unique geographic regions and then skillfully molded into a cast. Special care is taken to maximize nature's beauty of the undercut for stunning realism. Once the mold creation process has been completed, it moves into production, and stones are meticulously colorized using raw pigment and oxides which provides richness to every stone. They also use superior shale aggregates while casting and each mixture of the base material is quality controlled for batch-to-batch consistency. This manufacturer has a leading-edge process and equipment to ensure that every step in creating each stone is optimized for aesthetics and consistency.





Next, once the concrete cinder blocks cure, we will begin to install the cultured stone veneer by hand. This is a time-consuming process that takes skill to properly install each piece. Performing the skillset allows for the stone veneer to look more natural once installed. The white backing you see in both images is made out of Azek<sup>TM</sup>. This product is made of a polyresin material that will never rot or deteriorate. The actual signage with the "Friendly Inn Settlement logo, will be fastened to the Azek<sup>TM</sup> backboard with stainless steel screws. These stainless-steel screws will not rust.





The two images below, depict how the sign will look. The actual sign that will be mounted on the back Azek<sup>TM</sup> board, will be artistically hand painted. The artisan who we have worked with for over 25 years, will utilize a high-grade auto body enamel paint. The sign will be an all-aluminum sign. The plantings that are in the image, will be donated if our company does the sign, are all low-maintenance perennials.





The first image below shows the high gloss all-aluminum sign. The Friendly Inn Settlement sign will be a white piece of aluminum. The image also illustrates the high gloss-protected enamel paint. The second image illustrates how the solar lights will illuminate the sign at twilight.





All work will be completed in a neat and professional manner. All material is guaranteed to be as specified. #### Scope of Work Summary
